### Bequest by Will

### Cash or Securities Gift

A direct gift of cash or securities is the simplest way of making a gift to the Waynesboro Area YMCA. With this type of donation, the IRS may allow you to take a charitable deduction equal to the gift's fair market value on the date of the gift.
